

INTRODUCTION AND OBJECTIVE

igeria LNG Limited (NLNG) produces Liquefied Natural Gas ("LNG") and associated products from a six (6) train facility located on Bonny Island in Rivers State. As part of its growth plans, NLNG and its Shareholders intend to build a seventh natural gas liquefaction train ("NLNG Train 7") at its plant complex on Bonny Island.

In order to maximise the utilization of Nigerian manufactured, fabricated and assembled equipment, materials and services, NLNG and its Shareholders, in conjunction with the Nigerian Content Development and Monitoring Board ("NCDMB"), and in accordance with the provisions of the Nigerian Oil and Gas Industry Content Development ("NOGICD") Act, 2010 hereby invite interested and capable contractors, suppliers, manufacturers based in Nigeria, local representatives of Original Equipment Manufacturers' (OEMs) in Nigeria, vendor groups/associations, trades and supplier associations offering relevant products and services in the Nigerian Oil and Gas industry to a Public Workshop. The workshop is aimed at sensitizing members of the public and stakeholders to the Nigerian Content opportunities in the development of NLNG Train 7.

The Public Workshop also presents a forum for the identification of local supply chain capabilities/potentials for the in-country provision of materials and services to support the construction of the following components/units and associated facilities of the NLNG Train 7 project:

- 1) Complete Train ("CT")
- 2) Common Liquefaction Unit ("CLU)
- 3) New flare system
- 4) Tie-ins to the existing plant
- 5) Third LNG Jetty
- 6) Supporting on-site infrastructure
- 7) Supporting off-site infrastructure

HIGH LEVEL NIGERIAN CONTENT ("NC") OPPORTUNITIES

The anticipated NC opportunities for the NLNG Train 7 project include (without limitation) the following:

- Fabrication & Construction of non-cryogenic, pressure vessels & heat exchangers;
- Assembly of non-cryogenic valves, pumps and associated facilities;
- Construction of jetty and export/loading and offloading systems for LNG and associated products;
- Pipelines systems fabrication/construction, cable laying, coatings etc.;
- Paints manufacture/supply, electrical cables, foundry materials, sacrificial anodes etc.;
- Civil construction of temporary and permanent structures;
- Materials procurement and supply services;
- Health, Safety and Environment services;
- Process automation and control/information;
 Systems/Information Technology/Radio & Communication Services;
- Installation, hook-up and commissioning;
- Inspection, testing & certification; and
- Oil & Gas training and certification
